- 1. We want freedom. We want power to determine the destiny of our black community.
- 2. We want full employment for our people.
- 3. We want an and to the robbery by the white man of our black community.
- 4. We want decent housing, fit for shelter of human beings.
- 5. We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present day Society.
 - 6. We want all black men to be exempt from military service.
 - 7. We want an immediate end to police brutality and murder of black people.
 - 8. We want freedom for all black men held in federal, state, county and city prisons and
- 9. We want all black people when brought to trial, to be tried in court by a jury of their peer group or people from their black communities, as defined by the constitution of the United States.
- 10. We want land, bread, housing, education, clothing, justice and peace. and as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny.

We believe that black people will not be free until we are able to determine our destiny.

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed income. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all its people and give a high standard of living.

We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered 6,000,900 Jews. The American racist has taken part in the slaughter of over 50,000,000 black people Therefore, we feel that this is a modest demand that we make.

We believe that if The white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community

with government aid, can build and make decent housing for its people.

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything else.

We believe that black people should not be forced to fight in the military service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military by whatever means necessary.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The second amendment of the Constitution of the United States gives us a right to bear arms. We therefore believe that all black people should arm themselves for self defense.

We believe that all black people should be released from the man's jails and prisons because they have not received a fair and impartial trial.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a man a right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all white juries that have no understanding of the "average man" of the black community.
